To the members of the Alpha Sigma chapter of Kappa Sigma,

In accordance with the Registration Guidelines for Student Organizations and the Code of Student Conduct, I have determined reasonable cause exists to believe that the activities of the Alpha Sigma chapter of Kappa Sigma, pose a significant risk of substantial harm to the safety and security of its members, potential new members and others. This determination is based on allegations involving hazing during the spring 2020 semester.

As a result, I hereby place the Alpha Sigma chapter on interim suspension and temporarily discontinue the Alpha Sigma chapter's registration as a recognized student organization of The Ohio State University, pending a full investigation of this matter by the Office of Student Life Student Conduct.

Terms of interim suspension

During the period of this interim suspension, the Alpha Sigma chapter shall not be eligible to participate in any recognized student organization activities, including but not limited to chapter meetings or programs, Greek Council meetings and sponsored activities, Welcome Week activities, intramural sporting events, Greek Week, recruiting of new members, chapter social events or social events with any other student organizations. In addition, all membership intake activities must cease during the period of interim suspension.

Failure to comply

Failure to adhere to the terms of this interim suspension will subject the chapter and participating individual members to further disciplinary action under the Code of Student Conduct 3335-23-04 (G) for Failure to Comply with a University Official.

Notice to membership

You must forward this letter to all members and potential new members to place them on notice of the interim suspension. Further, this letter provides notice to individual members that they may be held responsible for failing to comply with the directives within this letter. Additionally, all members, like any students, are responsible for reading the Code of Student Conduct, including the following provisions:

Hazing

3335-23-04 (L) Hazing. Doing, requiring, or encouraging any act, whether or not the act is voluntarily agreed upon, in conjunction with initiation or continued membership or participation in any group that causes or creates a substantial risk of causing mental or physical harm or humiliation. Such acts may include, but are not limited to, use of alcohol, creation of excessive fatigue, and paddling, punching or kicking in any form. Failure to intervene, prevent, or report acts of hazing may constitute a violation of this section.

Student conduct system abuse

3335-23-04 (M) Student conduct system abuse. Abuse of any university student conduct system, including but not limited to:

(1) Failure to obey the summons or directives of a student conduct body or university official;

(2) Falsification, distortion, or misrepresentation of information before a student conduct body;

(3) Disruption or interference with the orderly conduct of a student conduct proceeding;

(4) Knowingly instituting a student conduct proceeding without cause;

(5) Discouraging an individual's proper participation in or use of, a university student conduct system;

(6) Influencing the impartiality of a member of a student conduct body prior to, and/or during the course of a student conduct proceeding;

(7) Harassment and/or intimidation of a member of a student conduct body prior to, during, and/or after a student conduct proceeding;

(8) Failure to comply with one or more sanctions imposed under the code of student conduct; and

(9) Influencing another person to commit an abuse of a university student conduct system.

Amnesty

3335-23-06 Amnesty. At the university's discretion, amnesty may be extended to students who may be hesitant to report a violation of the code to university officials because they fear that they themselves may be accused of minor policy violations, including but not limited to underage drinking, at the time of the incident. If a student is granted amnesty, an educational discussion or other informal resolution may be considered, but no university conduct proceedings under this code will result. At the university's discretion, amnesty may also be extended on a case-by-case basis for minor policy violations when students request assistance for others in need, including the person receiving assistance. If a student is granted amnesty, an educational discussion or other informal resolution may be considered, but no university conduct proceedings under this code will result. In cases of academic misconduct, need does not include the inability of a student to complete an assignment without assistance.

You must copy Student Conduct at studentconduct@osu.edu and the Director of Sorority and Fraternity Life at defreitas.12@osu.edu on the email sent to all members and new members within two hours of the receipt of this letter to ensure all members are aware of their individual responsibility during the interim suspension.

Request for reinstatement

The Alpha Sigma chapter has the right to request reinstatement or modifications of the interim suspension. Requests must be in writing and must include supporting documentation or evidence that the Alpha Sigma chapter (or the proposed modification) does not pose or no longer poses a significant risk of substantial harm to the safety or security of themselves or others or to property.

Submit your written request by email to <u>lovell.113@osu.edu</u>. Please consult the Code of Student Conduct, Section 3335-23-20, for a complete description of this process.

Notice to others

We will share notice of this interim suspension with other university officials, Kappa Sigma, and other necessary members of the university community, including your peer organizations.

Investigation

Finally, Student Conduct will soon send notice of its investigation, including the name and contact information of the assigned case manager. It is important that you meet with the case manager and follow all instructions and directives given to you by Student Conduct. Please know that any efforts by the Alpha Sigma chapter, its members or other students acting on its behalf that could be considered retaliation or student conduct system abuse will not be tolerated and could result in additional disciplinary action against the chapter or the involved individual students.

Student Conduct has received information that describes conduct by the Alpha-Sigma chapter of Kappa Sigma during the spring 2020 semester. I am investigating whether this conduct may have occurred and violated the following sections of the university's Code of Student Conduct:

- 3335-23-04 (L) Hazing. Doing, requiring or encouraging any act, whether or not the act is voluntarily agreed upon, in conjunction with initiation, continued membership, or participation in any group, that causes or creates a substantial risk of causing mental or physical harm or humiliation. Such acts may include, but are not limited to, use of alcohol, creation of excessive fatigue, and paddling, punching or kicking in any form. Failure to intervene, prevent, or report acts of hazing may constitute a violation of this section.
- 3335-23-04 (B1) Endangering behavior. Taking or threatening action that endangers the safety, physical or mental health, or life of any person, or creates a reasonable fear of such action.
- 3335-23-04 (I) Alcohol. Use, underage intoxication, production, distribution, sale, or possession of alcohol in a manner prohibited under law or applicable university policy or facility policy.

As a leader of the organization, you must contact Student Conduct at 614-292-0748 **as soon as possible**, and no later than February 27, 2020, to schedule a preliminary conference with me. The purpose of this conference is twofold. At this meeting, I will explain our process for determining whether charges for violations are warranted, and will answer any questions you may have about the conduct process. We will talk about what happened, and you will be able to identify any other individuals who may have information about the alleged incident. If you have any relevant materials, for example, your own written statement, text messages, photos, emails, etc., please email them to me at reistad.1@osu.edu before our meeting.

As stated in your interim suspension letter, you must bring the following information with you to the meeting, or you may submit it prior:

- A list of the names and contact information for:
 - all current members,
 - all new or initiated members that disaffiliated from the chapter during the spring 2020 semester, and
 - all potential new members or students who have indicated an interest in joining your chapter.
- Contact information must include:
 - names
 - email
 - cell numbers
 - school rank
 - officer/leadership position (if any)
 - member status (new member, disaffiliated member, etc.).

As a leader of the organization, you are required to notify the entire membership of this matter as stated in the letter you received from Interim Dean of Students, Ryan Lovell. You must include this letter in that communication.

Should any individuals wish to provide information to me regarding this investigation they are encouraged to email me at <u>reistad.1@osu.edu</u>.

All members of the organization are advised that should they violate the directives listed in this letter that they will be charged as an individual student with the following policy:

3335-23-04(G) Failure to Comply with University or Civil Authority – Failure to comply with legitimate directives of authorized university officials, law enforcement or emergency personnel, identified as such, in the performance of their duties, including failure to identify oneself when so requested; or violation of the terms of a disciplinary sanction.

You may bring one advisor and a registered co-leader (if applicable) to your preliminary conference. Your advisor can be any person who is not involved as a witness or other participant in the case. Upon request, Student Life's Student Advocacy Center (<u>http://advocacy.com</u>) is able to provide information and assistance in this process.

You will find the <u>Code of Student Conduct</u> and information about our process at <u>http://studentconduct.osu.edu</u>. Additionally, I have attached a Statement of Student Rights and Responsibilities to this letter.

Students are responsible for requesting accommodations when they feel they are needed. Should you need an accommodation based on the impact of a disability during the Student Conduct process, please contact the university's ADA Coordinator's office at 614-292-6207 (voice), 614-688-8605 (TTY), <u>ada-osu@osu.edu</u>, or visit <u>https://ada.osu.edu/</u>. One week's notice will allow for seamless access. Should you need additional time in order to seek any appropriate accommodation, please contact me immediately.

If you, or a representative from your organization, fail to contact our office by February 27, 2020, to schedule your preliminary conference meeting, I may continue this investigation without your input. This could result in charges, which may lead to a hearing and sanctions if found in violation.

Student Rights and Responsibilities

The Code of Student Conduct provides the procedures and definitions used to respond to complaints regarding students' behavior. Many of the rights and responsibilities found in the Code of Student Conduct are highlighted below. For a full review of all the rights and responsibilities given to students please refer to the Code of Student Conduct, which can be found at <u>www.studentconduct.osu.edu</u>.

- Students shall receive written notice of university charges, through one of multiple methods of communication, including: in person; in a residence hall mailbox; by email to official university email address, which may then direct the student to vie the notice in a secure website; by text message or other electronic communication; or by mail to a local or permanent address. (3335-23-08-A)
- Students are afforded the opportunity to meet with a university official following the notification of charges. (3335-23-08-C)
 - University staff members authorized to investigate complaints usually request a meeting with students prior to issuing charges.
 - Once charges are issued, students can request another meeting.
 - Students are strongly encouraged to meet with a university official.
- Students may choose to bring an advisor (i.e., support person) for support throughout the disciplinary process. (3335-23-12-C)
 - \circ $\;$ The advisor may be any person other than a witness.
 - The advisor may only counsel the student and may not actively participate in the process.
- Students are offered options for the resolution of charges. (3335-23-08-D)
 - Generally, students may choose between an administrative hearing or a hearing before the University Conduct Board to resolve charges other than those related to:
 - Academic Misconduct (3335-23-04-A)
 - Discrimination and harassment, including, but not limited to sexual misconduct, based on a protected class, prohibited by university policies 1.15 and 1.10, which can be found at http://policies.osu.edu. (3335-23-02-C)
 - NOTE: If students fail to respond to the initiation of charges and there is enough information to support finding a violation, the hearing officer may issue an administrative decision, as long as the sanctions do not include suspension or dismissal. (3335-23-09)
- An administrative decision allows the student to admit, in writing, to the violation(s), and serves as a request to have appropriate sanctions made by the hearing officer, rather than having charges referred to a hearing body. (3335-23-09)

- In these cases, the student waives rights to a hearing and any procedural guarantees that come from taking part in a hearing.
- Students have the opportunity to request a separate hearing and choose either an administrative (with one university official) or board hearing, except under special circumstances. (3335-23-10-C)
 - Students will receive notice of the hearing at least 10 calendars prior to the hearing, including all charge(s), logistical information, and statement of student's rights. (3335-23-11-C)
 - The respondent may request to postpone the hearing for a reasonable cause, which must be made in writing and received by the person sending the hearing notification at least 2 business days in advance. Decisions on postponements are made at the discretion of the university. (3335-23-11-D)
 - Attendance at hearings, though not mandated is strongly encouraged, and also limited to, respondents and those directly involved or requested by the hearing body.
 - Students will be informed of witnesses invited to attend the hearing by the university, and will be able to invite relevant factual witnesses to attend. (3335-23-12-D)
 - The respondent will have the opportunity to ask questions of all witnesses.
 - A single record of the proceedings, consisting of written notes, audio recording, or another method determined by the hearing body will be made. This will remain the property of the university but will be made available to the respondent for review during the appeal period. (3335-23-14)
 - Students will only be found in violation if a preponderance of evidence supports the charges. (3335-23-12-E)
- Students found in violation of the code, or who accept responsibility for violating the code, will receive sanctions that should be commensurate with the violations found to have occurred. (3335-23-17)
 - A disciplinary sanction: a formal reprimand; disciplinary probation; suspension; or dismissal, will be given in addition to (in most cases) educational outcomes.
- Students found to have violated the code of student conduct have the right to appeal the original decision. (3335-23-18)
 - All appeals must be sent within five working days after the date on which notice of the decision was sent to the student, unless the deadline was extended in response to an extension request as described in 3335-23-18-A(2).
 - Students who accept responsibility through an administrative decision waive their right to appeal, except on the basis that the disciplinary sanction is grossly disproportionate to the violation(s) committed.

- Students are limited to one appeal of a decision, and the decision of the appeal officer is final.
- Information on how to submit an appeal, including grounds for appeal, will be included with communication following a decision from the appropriate hearing body.

Guidelines for Remote Conduct Hearings

- 1. We will use Carmen Zoom to conduct your administrative hearing.
- 2. You are responsible for the following:
 - a. providing the computer and/or necessary telecommunications equipment and internet access for the hearing,
 - b. arranging a location with sufficient lighting and privacy that is free from distractions or intrusions for the duration of the hearing.
- 3. We will work with you to identify an alternative communication method (most often phone) in the event that Carmen Zoom fails.
- 4. While Carmen Zoom meetings are secure and private, there is always a risk that the transmission of your information could be disrupted or distorted by technical failures; the transmission of your information could be intercepted by unauthorized persons, and/or the electronic storage of your information could be accessed by unauthorized persons. To reduce these risks you may not share the Carmen Zoom meeting invitation information with anyone.
- 5. If you have trouble connecting to Carmen Zoom for your hearing, please call 614-292-0748 and ask for your Administrative Hearing Coordinator. If you do not engage in the scheduled hearing AND fail to provide notice of a technical difficulty by calling 614-292-0748, we will consider you absent for your hearing. The Code of Student Conduct section 3335-23-13 provides:

Because the most accurate and fair review of the facts can best be accomplished when all parties are present, the respondent and invited witnesses are strongly encouraged to attend and participate. If an individual does not choose to attend a hearing, the charges will be reviewed as scheduled on the basis of the information available, and a decision will be made. Although no inference may be drawn against a student for failing to attend a hearing or remaining silent, the hearing will proceed and the conclusion will be based on the evidence presented. No decision shall be based solely on the failure of the respondent to attend the hearing or answer the charges. In special circumstances, written statements may be considered by the hearing body when a respondent or witness does not attend or fully participate in a hearing.

- 6. You may not record your hearing. Student Conduct will make an audio recording, which you can review through the appeal period in your case.
- 7. You may not have any individuals in the room with you during your hearing other than one person acting as your advisor who is introduced by name at the start of the hearing.

- 3335-23-04 (M8) Student conduct system abuse Failure to comply with sanctions. Failure to comply with one or more sanctions imposed under the code of student conduct.
- 3335-23-04 (I) Alcohol. Use, underage intoxication, production, distribution, sale, or possession of alcohol in a manner prohibited under law or applicable university policy or facility policy.

On January 25-26, 2020, the chapter violated the Code of Student Conduct by engaging/or attempting to engage in conduct, that includes, but is not limited to, hosting a party where alcohol was present. At the event, underage individuals were provided and consumed alcohol. This violates the sanctions from cases **Statement**, delivered in an outcome letter on October 4, 2019. The sanctions prohibit the chapter from hosting events with alcohol until January 15, 2022.

Case

• 3335-23-04 (L) Hazing. Doing, requiring or encouraging any act, whether or not the act is voluntarily agreed upon, in conjunction with initiation, continued membership, or participation in any group, that causes or creates a substantial risk of causing mental or physical harm or humiliation. Such acts may include, but are not limited to, use of alcohol, creation of excessive fatigue, and paddling, punching or kicking in any form. Failure to intervene, prevent, or report acts of hazing may constitute a violation of this section.

During the January and February 2020 semesters, the chapter violated the Code of Student

Conduct by directing and/or encouraging new members to participate in early morning workouts approximately twice a week.

Finding

Case

At the hearing, your chapter contested the charge stating this was not a chapter event. You presented a witness that confirmed the same representation of the event. Additionally, you shared that this event was not hosted at an annex property and no Kappa Sigma members live at the residence. You identified that 11 active members of the fraternity attended the event with members being under the age of 21. If of the members under the age of 21 were held accountable and suspended from the fraternity.

Using the preponderance of evidence standard to weigh the information provided at the hearing, including that found in the hearing packet and the testimony offered by you,

, and other invited witnesses, I find your chapter **not in violation** of the Code of Student Conduct.

Case

At the hearing, your chapter contested the charge stating hazing is not part of the pledging experience. Pledges were encouraged to go to the RPAC for an opportunity to bond with their pledge brothers as the chapter values mental and physical well-being. You stated this activity is a tradition, voluntary and not part of the official pledge activities.

Witnesses corroborated that the pledges agreed upon a time for the activity. The only time all members of the pledge class were available to participate in the activity was 6:30 a.m. BuckID swipes confirm that between 19-31 pledges of a class of 44 and active members entered the RPAC on the same days, within the same timeframe, for 6 weeks.

During the hearing, provided an example of how he communicated this was a voluntary activity to the pledge class. He stated a pledge texted him to apologize for not being able to participate in the RPAC activity due to an injury. The replied that he didn't know why the pledge was texting him because it's not required. The stated he texted the rest of the pledge class reminding them this was not a required activity.

While this example does show an effort to remind the pledge class that this was voluntary, the Code of Student Conduct states hazing can occur whether an activity is voluntarily agreed upon. Additionally, this example shows that members of the pledge class interpreted the event as encouraged/required by the chapter.

Using the preponderance of evidence standard to weigh the information provided at the hearing, including that found in the hearing packet and the testimony offered by you, and witnesses, I find your chapter **in violation** of the Code of Student Conduct.

Sanction

Revocation

On October 4, 2019, the University Conduct Board issued sanctions for violations from two previous cases. Sanctions included deferred revocation of your chapter's status as a registered student organization and disciplinary probation through May 7, 2023. The letter states, "…any further violation of the Code of Student Conduct, while on probation will result in the immediate revocation of your chapter's status as a registered student organization."

Therefore, I have no choice but to revoke your chapter's status as a registered student organization.

This outcome letter does not replace or nullify any sanctions or stipulations set forth by prior outcome letters, your organization's headquarters, advisors, Sorority and Fraternity Life or the IFC.

The chapter's registration as a student organization is revoked effective Monday, July 6, 2020, or upon the date of an appeal decision (if the chapter submits an appeal and the revocation is upheld) through August 4, 2024.

With the chapter's revocation of recognition as a registered student organization at Ohio State, your chapter no longer has the rights and privileges afforded to a recognized fraternity or student organization. Those rights and privileges include, but are not limited to, the following:

- Listing in the online student organization directory
- \$250 line-of-credit to be used in the Resource Room
- Opportunity to apply for Operating Funds and Programming Funds
- Discounted rates for on-campus space reservations
- Opportunity to register for the Student Involvement Fair
- Opportunity to register for the Homecoming Parade
- Opportunity to apply for office or locker space in the KBK Center for Student Leadership and Service
- Access to Student Organization Success Coaches
- Access to enhanced training and workshops through Student Activities
- Access to free marketing resources
- Access to free website hosting, email address and/or email listserv
- Participation in governing council and SFL community events and programming put on by SFL staff or the Greek Programming Board
- Membership in honor societies such as Order of Omega
- New and active member ongoing education via the Standards of Excellence program and council programming
- Recognition in the Sorority and Fraternity Life Awards program
- Ability to host social events with the National Panhellenic Conference (NPC) sororities and their members in the Panhellenic Association.

Students using your organization's name or likeness (e.g., Greek letters) or otherwise claiming to act as Kappa Sigma while engaging in behavior that violates the Code of Student Conduct are

subjecting themselves to potential disciplinary action in their individual capacities, which could result in sanctions up to and including dismissal from the university. Likewise, if they are operating on behalf of Kappa Sigma, this could open a new case against your organization that potentially could extend your revocation term.

Reestablishment

Kappa Sigma's international organization must begin communication one year prior to reestablishing, but no sooner than January 1, 2023.

In discussing its return to our community, Kappa Sigma representatives must meet with the Director of Sorority and Fraternity Life, or designee, to discuss the current campus environment and what requirements must be completed before the reestablishing process and during the chapter's first year. These conversations will occur in consultation with the Director of Student Conduct, or designee.

In determining whether to permit reestablishment of a chapter at Ohio State in August of 2024, Sorority and Fraternity Life and Student Conduct will take into consideration the organization's efforts to remedy or eliminate underground activity while the chapter remains deactivated. I encourage Kappa Sigma representatives to provide Student Conduct with any documentation related to these efforts.

I invite the international organization to submit a memorandum identifying actions it will take when re-joining our campus community. Memorandum topics could include:

- recruitment strategies
- new member reviews and criteria
- alumni and advisor involvement
- selection of consultants and new chapter coordinators
- new member education plans
- alcohol and risk management policies

This optional submission is due no later than July 31, 2020.

The Office of Student Life will contact parents and families of organization members and potential new members to inform them of this outcome and provide additional care and support resources available to their student.

Chapter Communication Plan

It is important that all members, new members, and those who work closely with the chapter be aware of this outcome. Students using your organization's name or likeness (e.g., Greek letters) or otherwise claiming to act as Kappa Sigma while engaging in behavior that violates the Code of Student Conduct are subjecting themselves to potential disciplinary action in their individual capacities, which could result in sanctions up to and including dismissal from the university.

Thus, at the end of the appeal period, the chapter is required to email this outcome letter to:

- all new and active members
- all local and alumni advisors
- the housing corporation/board and/or landlord/property owners for the chapter house
- all landlord/property owners for any "annex" houses

You must copy me on this communication so that I can verify completion. Failure to send this communication to all new and active members will result in a charge being issued for 3335-23-04 (M8) Student conduct system abuse.

Requests for Extensions and Modifications

Any request for an extension or a modification of any outcome must come from the chapter president to <u>reeb.47@osu.edu</u>. The request must contain a detailed explanation of the reason for the request.

Staffing Change

Should Student Conduct no longer employ me or if my role were to change, another staff member will monitor sanction completion. To account for such a change, please include the general Student Conduct email on all sanction items. That address is <u>studentconduct@osu.edu</u>.

Appeal

An organization found to have violated the Code of Student Conduct has the right to appeal. To do so, you must submit your appeal in writing, addressed to the Vice President for Student Life, no later than 4:00 pm on Monday, July 13, 2020. You should use the online appeal form found at <u>https://go.osu.edu/appeals</u>, or the form attached to this letter to submit your appeal. If you elect to use the attached document, please scan and email it by the deadline to <u>reeb.47@osu.edu</u>.

If you do not submit an appeal, this decision will be effective at the end of your appeal period.

Upon request, Student Life's Student Advocacy Center (<u>http://advocacy.osu.edu</u>) is able to provide information and assistance about this process, including the possible impact that any assessed sanctions may have on you.

STUDENT CONDUCT APPEALS

Student Appeals

- A student or organization found to have violated the Code of Student Conduct has the right to appeal the original decision. The appeal is not intended to re-hear or re-argue the same case, and is limited to the specific grounds outlined below. The appeal must state the specific grounds for the appeal and should include all supporting documentation. The appeal must be postmarked or hand delivered to the appropriate appeal officer, or sent via email, by the deadline provided in the decision letter, which is usually five (5) working days after the date on which notice of the decision is sent to the student. Each student or organization shall be limited to one appeal. The decision of the appeal officer is final.
- In cases involving charges relating to sexual harassment as defined in applicable university policy, the victim may appeal the original decision. Such charges include, but are not limited to, sexual misconduct and stalking.
- A student who (or organization that) has accepted responsibility (Administrative Disposition) for violating the Code of Student Conduct waives the right to appeal, except on the basis that the disciplinary sanction is grossly disproportionate to the violation(s) committed.
- Each party shall be limited to one appeal. The decision of the appeal officer is final.

Grounds for appeal

An appeal may be based only upon one or more of the following grounds:

1. Procedural error that resulted in material harm or prejudice to the student (i.e., by preventing a fair, impartial, or proper hearing). Deviations from the designated procedures will not be a basis for sustaining an appeal unless material harm or prejudice results;

2. Discovery of substantial new evidence that was unavailable at the time of the hearing, and which reasonably could have affected the decision of the hearing body; or

3. Disciplinary sanction imposed is grossly disproportionate to the violation(s) committed, considering the relevant aggravating and/or mitigating factors.

Non-attendance by the accused student may not be the sole grounds for an appeal. Dissatisfaction with a decision is not grounds for appeal.

Appeal Procedure

- 1. Complete the Appeal Request Form, including signing the form.
- 2. If applicable, attach supporting documentation.
- 3. Turn in the signed form and any added documentation to Student Conduct by the deadline. Student Conduct will ensure that the appeal officer receives the appeal and the record of the case.
- 4. Students neither meet with nor make oral presentations to the appeal officer, except at the request of the appeal officer in order to obtain relevant information.
- 5. Students who do not submit their appeals by the date/time specified in their decision letter waive their opportunity to appeal.
- 6. Students who do not provide information concerning the basis of their appeal waive their opportunity to an appeal.

Below, we examine the literal contentions of this regulation as it applied in this case, as well as the underlying values, which we hold to be equally as important.

- 2. Does the activity risk emotional or physical harm/abuse? NO. The voluntary trips to the RPAC were unsupervised, unprompted by active members, and
- 3. Would I object to this activity being photographed for the school newspaper or filmed by the local TV news crew? NO. We would be proud to know that our new members were taking full advantage of all of the amenities the Ohio State University has to offer.
- 4. Would I feel uncomfortable participating in this activity if my parents, professor, coach or university official were watching? NO.
- 5. Would we get in trouble if the Director of Student Conduct walked by? NO
- 6. Am I being asked to keep these activities a secret? NO. Nobody was ever asked to keep these activities a secret. In fact, the information was volunteered to the Office of Student Conduct by chapter leadership.
- 7. Am I doing anything illegal? NO. Performing voluntary physical exercise is not illegal.
- 8. Does participation violate my values or those of my organization? NO. Both the school and Kappa Sigma believe in the value of balancing academic, social, and physical wellness.
- Is this activity causing emotional distress or stress of any kind to myself or others? NO. Nobody was asked to participate, much less encouraged to, or in any way pressured to do so.

10. Are we using university equipment in violation of the university student handbook or RPAC regulations? - NO

One of the questions to "Ask Yourself" to determine if hazing is being used can be found in Section 3335-23-04, "Would active, current members of the group refuse to participate in this activity with the new members and do exactly the same activity?" Our chapter believes its 80-man Kappa Sigma chapter would answer "NO". The Kappa Sigma National Headquarter education doctrine for pledges does not cover health and fitness. Kappa Sigma at The Ohio State University does believe in health and fitness and would share equally in an RPAC experience with others be they pledges, friends or members.

Another question found in Section 3335-23-04, "Does the activity risk emotional or physical harm/abuse?" The Ohio State University has one of our Nation's finest facilities in the RPAC. Undergraduate and graduate students are thrilled to use it. RPAC is also on the short list of must-see facilities for parents and friends when visiting. RPAC, the Oval and Mirror Lake, the Ohio Union, the Oxley-Thompson Library and more. Learning that pledges voluntarily went for fitness without fear of risk isn't surprising and as young persons they do not view physical harm from a work-out as being risky. Emotional harm is subjective but the fitness regime didn't appear to threaten the pledge class' spirit for wanting to join Kappa Sigma.

There are eight more questions which helps to organize a student's understanding of the ideas or concept of hazing. Kappa Sigma members would answer NO to all of them except, "If someone were injured, would I feel comfortable being investigated by the police or insurance carrier?" Members would have no issue answering questions.

The hazing investigation was spurred by a fictitious anonymous account, which was proven not to be true. In the process of the investigation, information was volunteered as we did not believe it to be hazing for our pledges to have conducted public, voluntary workouts. The pledges themselves, during the course of the investigation, have repeatedly stated that they were not hazed, and as such, there is no basis for a hazing charge. Additionally, the actives who did attend, were doing so not to "supervise" or "oversee" the activity, but rather to pursue their own fitness goals while participating in a common act of brotherhood. The actions found in violation of the university code did not in fact violate university code, because there was nothing mandatory nor harmful of stemming from the opportunity to participate in physical activity with peers.

In closing, Kappa Sigma asks that the Office of Student Conduct rescind the recent decision to revoke its student organization (Kappa Sigma) status with Student Life and Greek

Life. This Appeal is our act of contrition for being so uninformed on the merits of one very poor decision which was to engage in a manner seen as an act of hazing.

There are eight more questions which helps to organize a student's understanding of the ideas or concept of hazing. Kappa Sigma members would answer NO to all of them except, "If someone were injured, would I feel comfortable being investigated by the police or insurance carrier?" Members would have no issue answering questions.

The hazing investigation was spurred by a fictitious anonymous account, which was proven not to be true. In the process of the investigation, information was volunteered as we did not believe it to be hazing for our pledges to have conducted public, voluntary workouts. The pledges themselves, during the course of the investigation, have repeatedly stated that they were not hazed, and as such, there is no basis for a hazing charge. Additionally, the actives who did attend, were doing so not to "supervise" or "oversee" the activity, but rather to pursue their own fitness goals while participating in a common act of brotherhood. The actions found in violation of the university code did not in fact violate university code, because there was nothing mandatory nor harmful of stemming from the opportunity to participate in physical activity with peers.

In closing, Kappa Sigma asks that the Office of Student Conduct rescind the recent decision to revoke its student organization (Kappa Sigma) status with Student Life and Greek

Life. This Appeal is our act of contrition for being so uninformed on the merits of one very poor decision which was to engage in a manner seen as an act of hazing.

First, we would like to state the purpose of this letter, and to thank you for your consideration of our plea. As an organization, but also as a group of student leaders, we want our actions to coincide with the values and mission of the university which we attend and love. It would be unthinkable for us, as stewards of the new members which have grown to become friends and brothers to us, to put those who are in our care in harm's way. As such, this letter of appeal is in regards to the decision and subsequent suspension of the OSU Kappa Sigma chapter as a result of <u>Case</u>

We strongly believe that the action for which this sanction has been placed on our organization does not violate the aforementioned section of the Student Code of Conduct. We would like to offer some contentions for your consideration, which we believe would exonerate us as an upstanding group of young men, behaving in accordance with the values and regulations of the Ohio State University. Below, we examine the literal contentions of this regulation as it applied in this case, as well as the underlying values, which we hold to be equally as important.

Here is a list of questions, which speak to

- 1. Would active, current members of the group refuse to participate in this activity with the new members? NO.
- 2. Does the activity risk emotional or physical harm/abuse? NO. The voluntary trips to the RPAC were unsupervised, unprompted by active members, and
- 3. Would I object to this activity being photographed for the school newspaper or filmed by the local TV news crew? NO. We would be proud to know that our new members were taking full advantage of all of the amenities the Ohio State University has to offer.
- 4. Would I feel uncomfortable participating in this activity if my parents, professor, coach or university official were watching? NO.
- 5. Would we get in trouble if the Director of Student Conduct walked by? NO
- 6. Am I being asked to keep these activities a secret? NO. Nobody was ever asked to keep these activities a secret. In fact, the information was volunteered to the Office of Student Conduct by chapter leadership.
- 7. Am I doing anything illegal? NO. Performing voluntary physical exercise is not illegal.
- 8. Does participation violate my values or those of my organization? NO. Both the school and Kappa Sigma believe in the value of balancing academic, social, and physical wellness.
- Is this activity causing emotional distress or stress of any kind to myself or others? NO. Nobody was asked to participate, much less encouraged to, or in any way pressured to do so.
