



As a result, I hereby place the Ohio State Associate chapter on interim suspension pending a full investigation of this matter by the Office of Student Life Student Conduct.

Terms of interim suspension

During the period of this Interim Suspension, the chapter shall not be eligible to participate in any recognized student organization activities, whether in-person or "virtually," including but not limited to Chapter meetings or programs, Greek Council meetings and sponsored activities, Welcome Week activities, intramural sporting events, Greek Week, recruiting of new members, chapter social events or social events with any other student organizations. All new membership activities must cease during the period of Interim Suspension.

Failure to adhere to the terms of this interim suspension of chapter activities will subject the chapter and participating individual members to further disciplinary action under the Code of Student Conduct 3335-23-04 (G) for Failure to Comply with University Authority.

Notice to membership

You must forward this letter to all members/potential new member to place them on notice of the interim suspension. Further, this letter provides notice to individuals that they may be held responsible for failing to comply with the directives within this letter.

You must copy Student Conduct at studentconduct@osu.edu and the Director of Sorority and Fraternity Life at defreitas.12@osu.edu on the email sent to all members/new members within two hours of the receipt of this letter to ensure all members are aware of their individual responsibility during the interim suspension.

Request for reinstatement

The chapter has the right to request reinstatement or modifications of the interim suspension. Requests must be made in writing and must include supporting

documentation or evidence that the The Ohio State Associate chapter (or the proposed modification) does not pose or no longer poses a significant risk of substantial harm to the safety or security of themselves or others or to property. Submit your written request by email to lovell.113@osu.edu. Please consult the Code of Student Conduct, Section 3335-23-20, for a complete description of this process.

Notice to others

We will share notice of this interim suspension with other university officials, Delta Kappa Epsilon, and other necessary members of the university community, including your peer organizations.

Investigation

It is important that you continue to follow all instructions and directives given to you by Student Conduct. Please know that any efforts by the Ohio State Associate chapter, its members or other students acting on its behalf that could be considered retaliation or student conduct system abuse will not be tolerated and could result in additional disciplinary action against the chapter or the involved individual.



The report details concerns related to allegedly providing alcohol to potential/new members under the age of 21. I am investigating whether this conduct may have occurred and violated the following sections of the university's Code of Student Conduct:

- 3335-23-04 (L) Hazing. Doing, requiring or encouraging any act, whether or not the act is voluntarily agreed upon, in conjunction with initiation, continued membership, or participation in any group, that causes or creates a substantial risk of causing mental or physical harm or humiliation. Such acts may include, but are not limited to, use of alcohol, creation of excessive fatigue, and paddling, punching or kicking in any form. Failure to intervene, prevent, or report acts of hazing may constitute a violation of this section.
- 3335-23-04 (I) Alcohol. Use, underage intoxication, production, distribution, sale, or
 possession of alcohol in a manner prohibited under law or applicable university policy or
 facility policy.
- 3335-23-04 (B1) Endangering behavior. Taking or threatening action that endangers the safety, physical or mental health, or life of any person, or creates a reasonable fear of such action.

The purpose of this conference is twofold. At this meeting I will explain our process for determining whether charges for violations are warranted, and will answer any questions you may have about the conduct process. Many of the rights and responsibilities found in the Code of Student Conduct are highlighted below. - Students are afforded the opportunity to meet with a university official following the notification of charges. (3335-23-08-C)
 - o University staff members authorized to investigate complaints usually request a meeting with students prior to issuing charges.
 - o Once charges are issued, students can request another meeting.
 - o Students are strongly encouraged to meet with a university official.
- Students may choose to bring an advisor (i.e., support person) for support throughout the disciplinary process. (3335-23-12-C)
 - o The advisor may be any person other than a witness.
 - o The advisor may only counsel the student and may not actively participate in the process.
- Students are offered options for the resolution of charges. (3335-23-08-D)
 - Generally, students may choose between an administrative hearing or a hearing before the University Conduct Board to resolve charges other than those related to:
 - Academic Misconduct (3335-23-04-A)
 - Discrimination and harassment, including, but not limited to sexual misconduct, based on a protected class, prohibited by university policies 1.15 and 1.10, which can be found at http://policies.osu.edu. (3335-23-02-C)
 - o NOTE: If students fail to respond to the initiation of charges and there is enough information to support finding a violation, the hearing officer may issue an administrative decision, as long as the sanctions do not include suspension or dismissal. (3335-23-09)
- An administrative decision allows the student to admit, in writing, to the violation(s), and serves as a request to have appropriate sanctions made by the hearing officer, rather than having charges referred to a hearing body. (3335-23-09)
 - o In these cases, the student waives rights to a hearing and any procedural guarantees that come from taking part in a hearing.

- Students have the opportunity to request a separate hearing and choose either an administrative (with one university official) or board hearing, except under special circumstances. (3335-23-10-C)
 - Students will receive notice of the hearing at least 10 calendars prior to the hearing, including all charge(s), logistical information, and statement of student's rights. (3335-23-11-C)
 - The respondent may request to postpone the hearing for a reasonable cause, which must be made in writing and received by the person sending the hearing notification at least 2 business days in advance. Decisions on postponements are made at the discretion of the university. (3335-23-11-D)
 - o Attendance at hearings, though not mandated is strongly encouraged, and also limited to, respondents and those directly involved or requested by the hearing body.
 - Students will be informed of witnesses invited to attend the hearing by the university, and will be able to invite relevant factual witnesses to attend. (3335-23-12-D)
 - The respondent will have the opportunity to ask questions of all witnesses.
 - A single record of the proceedings, consisting of written notes, audio recording, or another method determined by the hearing body will be made. This will remain the property of the university but will be made available to the respondent for review during the appeal period. (3335-23-14)
 - O Students will only be found in violation if a preponderance of evidence supports the charges. (3335-23-12-E)
- Students found in violation of the code, or who accept responsibility for violating the code, will receive sanctions that should be commensurate with the violations found to have occurred. (3335-23-17)
 - O A disciplinary sanction: a formal reprimand; disciplinary probation; suspension; or dismissal, will be given in addition to (in most cases) educational outcomes.
- Students found to have violated the code of student conduct have the right to appeal the original decision. (3335-23-18)
 - O All appeals must be sent within five working days after the date on which notice of the decision was sent to the student, unless the deadline was extended in response to an extension request as described in 3335-23-18-A(2).
 - Students who accept responsibility through an administrative decision waive their right to appeal, except on the basis that the disciplinary sanction is grossly disproportionate to the violation(s) committed.

 - o NOTE: If students fail to respond to the initiation of charges and there is enough information to support finding a violation, the hearing officer may issue an administrative decision, as long as the sanctions do not include suspension or dismissal. (3335-23-09)
- An administrative decision allows the student to admit, in writing, to the violation(s), and serves as a request to have appropriate sanctions made by the hearing officer, rather than having charges referred to a hearing body. (3335-23-09)
 - o In these cases, the student waives rights to a hearing and any procedural guarantees that come from taking part in a hearing.

- Students have the opportunity to request a separate hearing and choose either an administrative (with one university official) or board hearing, except under special circumstances. (3335-23-10-C)
 - Students will receive notice of the hearing at least 10 calendars prior to the hearing, including all charge(s), logistical information, and statement of student's rights. (3335-23-11-C)
 - The respondent may request to postpone the hearing for a reasonable cause, which must be made in writing and received by the person sending the hearing notification at least 2 business days in advance. Decisions on postponements are made at the discretion of the university. (3335-23-11-D)
 - o Attendance at hearings, though not mandated is strongly encouraged, and also limited to, respondents and those directly involved or requested by the hearing body.
 - Students will be informed of witnesses invited to attend the hearing by the university, and will be able to invite relevant factual witnesses to attend. (3335-23-12-D)
 - The respondent will have the opportunity to ask questions of all witnesses.
 - A single record of the proceedings, consisting of written notes, audio recording, or another method determined by the hearing body will be made. This will remain the property of the university but will be made available to the respondent for review during the appeal period. (3335-23-14)
 - O Students will only be found in violation if a preponderance of evidence supports the charges. (3335-23-12-E)
- Students found in violation of the code, or who accept responsibility for violating the code, will receive sanctions that should be commensurate with the violations found to have occurred. (3335-23-17)
 - O A disciplinary sanction: a formal reprimand; disciplinary probation; suspension; or dismissal, will be given in addition to (in most cases) educational outcomes.
- Students found to have violated the code of student conduct have the right to appeal the original decision. (3335-23-18)
 - O All appeals must be sent within five working days after the date on which notice of the decision was sent to the student, unless the deadline was extended in response to an extension request as described in 3335-23-18-A(2).
 - Students who accept responsibility through an administrative decision waive their right to appeal, except on the basis that the disciplinary sanction is grossly disproportionate to the violation(s) committed.
 - o Students are limited to one appeal of a decision, and the decision of the appeal officer is final.
 - o Information on how to submit an appeal, including grounds for appeal, will be included with communication following a decision from the appropriate hearing body.

I am writing to provide the Delta Tau chapter of Delta Kappa Epsilon with my decision. The chapter took responsibility and requested an administrative decision for the following alleged violation(s) of the Code of Student Conduct:

- 3335-23-04 (L) Hazing. Doing, requiring or encouraging any act, whether or not the act is voluntarily agreed upon, in conjunction with initiation, continued membership, or participation in any group, that causes or creates a substantial risk of causing mental or physical harm or humiliation. Such acts may include, but are not limited to, use of alcohol, creation of excessive fatigue, and paddling, punching or kicking in any form. Failure to intervene, prevent, or report acts of hazing may constitute a violation of this section. In Violation
- 3335-23-04 (I) Alcohol. Use, underage intoxication, production, distribution, sale, or possession of alcohol in a manner prohibited under law or applicable university policy or facility policy. In Violation

Specifically, during the spring 2023 semester, the Delta Tau chapter of Delta Kappa Epsilon engaged or attempted to engage in conduct that includes, but is not limited to:

- Provided alcohol or made alcohol easily and readily available to new members and others, many of whom were under the age of 21
- Failed to curtail the availability of alcohol during the new member process or during new member activities

Sanction Consideration Student Conduct has continuously worked to support the chapter in redirecting behavior while serving as a direct resource to the organization. It has been the responsibility of the chapter to take advantage of and implement the learning and resources provided. There must be a collective decision to utilize these sanctioned opportunities for this organization to be successful here at The Ohio State University.

I considered the following factors in determining appropriate sanctions:

- the previous educational opportunities undertaken by the Delta Tau chapter of Delta Kappa Epsilon within the past academic year
- the outstanding sanctions of case
- our anticipation that Delta Kappa Epsilon International will be more involved in offering supervision and support in the chapter

Sanctions

All previous sanctions must be completed by August 1, 2023. Specifically, the Membership Recommitment Process must be the first sanction completed.

Student Conduct requires any outstanding sanctions from case to be completed by August 1, 2023, and before any steps are taken on sanctions listed below. Refer to the outcome letter issued on March 7, 2023, for full details.

The advisor and/or national representative will provide the outcome of the membership re-commitment process via email to Lacey Gosnell at gosnell.53@osu.edu for Student Conduct and Eddy Labid at labid.1@osu.edu for Sorority and Fraternity Life by August 1, 2023.

Identifying Local Advisors

Our investigation revealed that DKE frequently held events, including recruitment events, without an advisor present. For the 2023 – 2024 academic year, the chapter must identify at least five local advisors. At least one of the five local advisors must be present during all new member recruitment events and activities. The organization must collect the names, email addresses and phone numbers of the local advisors who agree to be present at events and provide this information Lacey Gosnell at gosnell.53@osu.edu and Eddy Labid at labid.1@osu.edu by August 14, 2023.

Review of the New Member Process

Your chapter will review and revise its new member process in consultation with the chapter's local advisors and DKE International staff members. The goal is to produce a new membership plan that creates an extraordinary new member experience and aligns with DKE standards and values.

To complete this review, your chapter will set up a process to:

- identify the purpose of the new member process (e.g., goals, experiences, learning outcomes) and evaluate how you can enhance the experience
- identify high-risk portions of the process (e.g., overnight activities, Big/Little reveal, social events with alcohol) that have traditionally involved hazing, alcohol or other drugs, or other risky behavior

- identify alternatives or new events to replace any events or activities that are identified as high-risk
- incorporate and address all applicable risk management requirements

Your chapter will develop a written plan that aligns the process with your intended purpose, while reducing the opportunities for high-risk situations to derail that purpose. This written plan will include:

- a summary of the review process identified above
- your new plan for the new member process including events, details of the events, how details of the process will be shared, where events will be held, how advisors will be recruited for the events
- how the replacement events you have created will reduce risk to active and new members
- your plans as a chapter to educate both new members and active members on expectations during the new member process and hazing
- how the chapter would report any concerning behavior that could happen during the new member process

To ensure successful recruitment for the 2023-2024 academic year, all recruitment events **must** be held at the chapter house or an OSU facility WITH a local advisor must be present.

During the investigation, current and new members reported that senior members brought alcohol to new member events. We expect that the Membership Recommitment Process will identify those seniors (or others) responsible for bringing alcohol to new member recruitment events. Those individuals must be prohibited from attending or participating in new member recruitment or other events. Accordingly, your chapter will create a list of alumni or former members who are not permitted to participate in any portion of the new member process, this includes but is not limited to recruitment, rush, and initiation events. This list must be included in the plan documentation.

Prior to implementing, and no later than August 14, 2023, you will email Lacey Gosnell at gosnell.53@osu.edu and Eddy Labid at labid.1@osu.edu a copy of the plan and schedule a follow-up meeting to discuss your review and proposed plan prior to its implementation for feedback.

Brandon will deliver a presentation to the chapter. After the presentation, you will create a summary about the presentation and the dialogue your members had around the topic area. A chapter advisor must be present at the presentation and sign off to approve your summary. Please attach a sign-in sheet to the summary to document that a minimum of 80% of your chapter members were present.

The presentation must be complete by October 27, 2023.

Alcohol Restriction

During the investigation, it was found that a potential new member was hospitalized due to their intake of alcohol at a DKE recruitment event. The chapter may not host or co-

host any events where alcohol is present until all sanctions are **complete**. I expect your chapter to engage with its members and community during this period, therefore you may host alcohol-free events. I strongly encourage you to work with your SFL Liaison Eddie Labid.1@osu.edu for information regarding scheduled, hands-on community events planned for the autumn semester in which the members of DKE can participate.

You must provide a copy of at least two registered alcohol-free events to me no later than **September 8, 2023**.

Social Event with Alcohol Requirements

Once your chapter has successfully completed all sanctions, the chapter will be able to host/co-host events with alcohol with the following requirements through May 5, 2024:

- 1. hire a third-party (independent, non-member) bartender to manage the distribution of BYOB alcohol, or
- 2. host the event at a third-party location with a bartender.

The purpose of this requirement is to support your chapter in hosting and co-hosting social functions in full compliance with risk management guidelines, state and local laws and statutes, and other applicable university policies.

I encourage you to consider making this requirement part of your common practice to enhance the safety of your guests and reduce risk to your chapter.

Appeal

Because you accepted responsibility, you may only appeal on the basis that the disciplinary sanction is grossly disproportionate to the violation committed.
