Student Conduct has received information that describes conduct by the Ohio Theta Chapter of Sigma Alpha Epsilon on September 21-22, 2019. I am investigating whether this conduct may have occurred and violated the following sections of the university's Code of Student Conduct:

- 3335-23-04 (M8) Student conduct system abuse Failure to comply with sanctions. Failure to comply with one or more sanctions imposed under the code of student conduct.
- 3335-23-04 (I) Alcohol. Use, underage intoxication, production, distribution, sale, or possession of alcohol in a manner prohibited under law or applicable university policy or facility policy.

# I am directing your chapter not to host any events where alcohol is present until further notice due to the nature of the allegations.

Thomas, as a leader of the chapter, you must contact Student Conduct **as soon as possible**, and no later than October 2, 2019, to schedule a preliminary conference with me. The purpose of this conference is twofold. First, I will explain and answer your questions about the Student Conduct process. Second, you will have the opportunity to explain what happened, to provide materials, and to identify other individuals with information about the alleged incident. You must bring your risk manager and advisor to this meeting. Your advisor can be any person who is not involved as a witness or other participant in the case. Employees of the university's Student Advocacy Center (http://advocacy.osu.edu) are available to provide advisor services or other support throughout this process upon request. To find out more information about these services or to request advisor services, please e-mail the Student Advocacy Center at advocacy@osu.edu.

You will find the Code of Student Conduct and information about our process at http://studentconduct.osu.edu. Additionally, I have attached a Statement of Student Rights and a description of the university's Hearing Procedures to this letter.

Students are responsible for requesting accommodations when they feel they are needed. # Student Rights and Responsibilities

The Code of Student Conduct provides the procedures and definitions used to respond to complaints regarding students' behavior. Many of the rights and responsibilities found in the Code of Student Conduct are highlighted below. For a full review of all the rights and responsibilities given to students please refer to the Code of Student Conduct, which can be found at <u>www.studentconduct.osu.edu</u>.

- Students shall receive written notice of university charges, through one of multiple methods of communication, including: in person; in a residence hall mailbox; by email to official university email address, which may then direct the student to vie the notice in a secure website; by text message or other electronic communication; or by mail to a local or permanent address. (3335-23-08-A)
- Students are afforded the opportunity to meet with a university official following the notification of charges. (3335-23-08-C)
  - University staff members authorized to investigate complaints usually request a meeting with students prior to issuing charges.
  - Once charges are issued, students can request another meeting.
  - Students are strongly encouraged to meet with a university official.
- Students may choose to bring an advisor (i.e., support person) for support throughout the disciplinary process. (3335-23-12-C)
  - $\circ$   $\;$  The advisor may be any person other than a witness.
  - The advisor may only counsel the student and may not actively participate in the process.
- Students are offered options for the resolution of charges. (3335-23-08-D)
  - Generally, students may choose between an administrative hearing or a hearing before the University Conduct Board to resolve charges other than those related to:
    - Academic Misconduct (3335-23-04-A)
    - Discrimination and harassment, including, but not limited to sexual misconduct, based on a protected class, prohibited by university policies 1.15 and 1.10, which can be found at http://policies.osu.edu. (3335-23-02-C)
  - NOTE: If students fail to respond to the initiation of charges and there is enough information to support finding a violation, the hearing officer may issue an administrative decision, as long as the sanctions do not include suspension or dismissal. (3335-23-09)
- An administrative decision allows the student to admit, in writing, to the violation(s), and serves as a request to have appropriate sanctions made by the hearing officer, rather than having charges referred to a hearing body. (3335-23-09)

- In these cases, the student waives rights to a hearing and any procedural guarantees that come from taking part in a hearing.
- Students have the opportunity to request a separate hearing and choose either an administrative (with one university official) or board hearing, except under special circumstances. (3335-23-10-C)
  - Students will receive notice of the hearing at least 10 calendars prior to the hearing, including all charge(s), logistical information, and statement of student's rights. (3335-23-11-C)
    - The respondent may request to postpone the hearing for a reasonable cause, which must be made in writing and received by the person sending the hearing notification at least 2 business days in advance. Decisions on postponements are made at the discretion of the university. (3335-23-11-D)
  - Attendance at hearings, though not mandated is strongly encouraged, and also limited to, respondents and those directly involved or requested by the hearing body.
  - Students will be informed of witnesses invited to attend the hearing by the university, and will be able to invite relevant factual witnesses to attend. (3335-23-12-D)
    - The respondent will have the opportunity to ask questions of all witnesses.
  - A single record of the proceedings, consisting of written notes, audio recording, or another method determined by the hearing body will be made. This will remain the property of the university but will be made available to the respondent for review during the appeal period. (3335-23-14)
  - Students will only be found in violation if a preponderance of evidence supports the charges. (3335-23-12-E)
- Students found in violation of the code, or who accept responsibility for violating the code, will receive sanctions that should be commensurate with the violations found to have occurred. (3335-23-17)
  - A disciplinary sanction: a formal reprimand; disciplinary probation; suspension; or dismissal, will be given in addition to (in most cases) educational outcomes.
- Students found to have violated the code of student conduct have the right to appeal the original decision. (3335-23-18)
  - All appeals must be sent within five working days after the date on which notice of the decision was sent to the student, unless the deadline was extended in response to an extension request as described in 3335-23-18-A(2).
  - Students who accept responsibility through an administrative decision waive their right to appeal, except on the basis that the disciplinary sanction is grossly disproportionate to the violation(s) committed.

- Students are limited to one appeal of a decision, and the decision of the appeal officer is final.
- Information on how to submit an appeal, including grounds for appeal, will be included with communication following a decision from the appropriate hearing body.

(3335-23-02 Jurisdiction) Your organization was aware of the event held on September 21-22, 2019, as three of four members of the Ohio Theta chapter of Sigma Alpha Epsilon (SAE) who live at the residence where the event was hosted, are on SAE's executive board.

Therefore, the Ohio Theta chapter violated the Code of Student Conduct by failing to comply with the sanction requirements found in cases and and any (e.g., trained and insured security services, third-party bartender, event registration, etc.) and providing, making available, and/or creating an atmosphere where one or more students under the age of 21 obtained alcohol and needed support due to intoxication.

#### **Sanction Consideration**

This outcome letter does not replace or nullify any sanctions or stipulations set forth by prior outcome letters, your organization's headquarters, advisors, Sorority and Fraternity Life or the IFC.

In determining appropriate and proportionate outcomes for this case, I considered the severity of

the violations when considered on a continuum. I also considered the chapter's previous conduct history, including previous sanctions, and the cooperation and engagement of the chapter, its members, and the local and national representatives from SAE.

## (1) Cooperation and Engagement

Throughout this investigation and adjudication process, I have seen much growth from not only the president of the Ohio Theta chapter, but its members. The members I met were open, transparent, and authentic. Members were not disappointed that they "got caught." Instead, they expressed genuine remorse about their failure to adhere to the values of their fraternity and brotherhood. The chapter was quick to do an internal investigation and hold its members accountable.

While my direct interactions with members gave me confidence in the Ohio Theta chapter's desire to be part of the Ohio State community, there is a clear systemic issue that exists between the general membership and its leadership. In both of the last two incidents, small sub-groups have made the active choice not to notify their leadership when holding events and instead chose hosting event's with alcohol as the priority.

The local and national representatives of SAE have been present and available to me throughout the entirety of the conduct process. They provided verbal and documented evidence of their commitment to support the Ohio Theta chapter today and moving forward. Because the chapter accepted responsibility for violations of the Code, I have engaged in direct, meaningful conversations with national representatives on how to deliver an outcome that addresses the severity of the behavior while also supporting the chapter's success. Key to that success is the commitment of local and national SAE representatives to hold the Ohio Theta chapter accountable to its own standards and the expectations of the university.

# (2) Prior Conduct History

Student Conduct issued an outcome letter on February 15, 2018 to the Ohio Theta chapter for violating the following sections of the Code of Student conduct: alcohol, endangering behavior, failure to comply with university or civil authority, and disorderly or disruptive conduct. Our office worked with your chapter to encourage compliance with the issued sanctions. Your chapter did not complete a non-alcohol event prior to moving onto the next step in your progressive return to hosting events with alcohol. Your chapter accepted responsibility for the following sections of the Code: failure to comply with one or more sanctions imposed under the code of student conduct. Your chapter's probation was extended in the March 18, 2019 outcome letter.

While Student Conduct was investigating the above concern, a small group of members hosted an unregistered event in the basement of SAE's chapter house where risk management practices, as described in the Joint Council Alcohol Risk Policy, were not followed. This resulted in approximately 8-12 active and newly initiated members of the chapter, and 2-4 guests, obtaining and consuming alcohol, some of whom were under the age of 21. Through a hearing with the University Conduct Board, the Ohio Theta chapter was found in violation for the alcohol policy. Due to the proximity in time of the last two incidents, no disciplinary sanction was issued, but additional educational sanctions were mandated. I share this previous conduct history in an effort to help you understand the extent Student Conduct has continued to support and educate the Ohio Theta chapter to become a model for hosting safe events and creating an environment consistent with the values of Ohio State and SAE. This information also details the chapter's ongoing issue to comply with university directives, in particular, its struggle with controlling sub-groups of the chapter.

# Outcome

# (1) Deferred Revocation of Registration

Therefore, based on the chapter's past conduct history, the chapter's cooperation throughout the process and the local and national organization's partnership and commitment to both support and hold the Ohio Theta chapter accountable, I have determined the most appropriate and proportionate response is the **deferred revocation of the chapter's registration** pending a membership review by SAE's national office. This membership review must be completed no later than **January 10, 2020**. If the chapter fails to complete this membership review and communicate the results, the chapter's status as a registered student organization will be revoked.

- SAE's national office will conduct a membership review and remove any members who are not willing or able to comply with the values of SAE and commit to abiding by the Code of Student Conduct. This review must be completed no later than January 10, 2020.
- A representative from SAE must meet with me and a member of Sorority and Fraternity Life to discuss the results of its membership review before January 17, 2020. You may schedule this meeting by emailing me at reeb.47@osu.edu with your availability.

# (2) <u>Probation</u>

The Ohio Theta chapter's probation is extended until May 7, 2023. Probation is a heightened state of warning that does not otherwise control or direct your chapter's functioning. Even after your chapter's probation period ends, we would consider its disciplinary history when considering sanctions for future violations, meaning revocation of registered status is still a likely outcome beyond the probationary period.

Additionally, I have reviewed all of your recommended sanctions and think they will be strategic and effective to re-build a membership which meets the expectations of SAE and Ohio State. In order to support you in this endeavor, you will be required to complete the following sanctions:

### (3) <u>Spring social probation</u>

As identified in your sanction recommendation, your chapter may not hold any events with alcohol through May 3, 2020.

I expect your chapter to host events without alcohol. Your chapter must learn how to build brotherhood and socialize without relying on the presence of alcohol. Accordingly, in consultation with your Sorority and Fraternity Life liaison, you must develop, plan and register a minimum of three (3) events during spring 2020, without the presence of alcohol. I strongly encourage your chapter to host more than three such events.

## (4) Hosting Privileges

Your chapter must focus on compliance with its risk management practices updated in response to a previous case. Your chapter is limited to having five (5) events where alcohol is present during the autumn 2020 semester.

Documentation for each event with alcohol must include the following to be considered compliant with this sanction:

- event registration for Sorority and Fraternity Life
- receipts for trained and insured security services and third-party bartender
- signed and dated guest list for the event
- documented evidence that BYOB policies were followed

Documentation of the above should include time-stamped photos of the sign-in table, wristbands, and guests with their individual servings of alcohol.

You will schedule two (2) meetings with me and a representative from Sorority and Fraternity Life to review compliance with these sanctions. You must come prepared with documentation proving your chapter's compliance. Meetings will be scheduled as follows:

- 1st meeting No later than August 28, 2020 to discuss your event schedule for the semester.
- 2nd meeting No later than December 11, 2020, to discuss any events where alcohol was present and to review your documentation.

If all policies and procedures are followed during the autumn 2020 semester, your chapter will be permitted to return to having the number of social events with alcohol as identified by IFC and/or Sorority and Fraternity Life. Additionally, if your chapter does not attend these meetings and/or comply with this sanction, further limitations may be placed on your chapter's ability to hold events where alcohol is present.

### (5) <u>Alumni advisory board established</u>

While every chapter's needs are different, I see continued effectiveness when chapters have a strong local presence. You will work with your national organization to develop an alumni advisory board, which will – as described in your proposed document—"create an environment of change and provide a culture shock to our fraternity and use this help from the alumni board to steer this fraternity in a new direction. This alumni board will reach their arms into many aspects of the fraternity including; funding, philanthropy, social, ritual, scholarship, and brotherhood."

You will send me monthly updates beginning January 31, 2020 regarding your progress establishing an alumni advisory board throughout the spring 2020 semester. By May 3, 2020, you must send me a list and contact information (phone and email) for those who sit on your alumni advisory board and three strategic goals you plan to accomplish in the 2020-2021 academic year developed in consultation with the board. These can include campus engagement, funding, philanthropy, social, ritual, scholarship, and/or brotherhood.

### **Requests for Extensions and Modifications**

Any request for an extension or a modification of any outcome must come from the chapter president to reeb.47@osu.edu. The request must contain a detailed explanation of the reason for the request.

#### **Staffing Change**

Should Student Conduct no longer employ me or if my role were to change, another staff member will monitor sanction completion. To account for such a change, please include the general Student Conduct email address on all sanction items. That address is studentconduct@osu.edu.

#### Appeal

A student or organization found to have violated the Code of Student Conduct has the right to appeal. To do so, you must submit your appeal in writing, directed to the Senior Vice President for Student Life, no later than 4 p.m. on December 9, 2019. Use the online appeal form found at https://go.osu.edu/appeals to submit your appeal. You may also submit a written appeal using the form attached to this letter. Please turn in the signed form along with any relevant documentation to the Office of Student Conduct, 550 Lincoln Tower, 1800 Cannon Dr., Columbus, OH 43210, by the deadline.

Because your chapter accepted responsibility for the charges and requested an administrative decision, your appeal may only be based on the single ground that the sanctions given were grossly disproportionate to the violations.

If you do not submit an appeal, this decision will be effective at the end of your appeal period.

Students are responsible for requesting accommodations when they feel they are needed. # **STUDENT CONDUCT APPEALS**

#### **Student Appeals**

- A student or organization found to have violated the Code of Student Conduct has the right to appeal the original decision. The appeal is not intended to re-hear or re-argue the same case, and is limited to the specific grounds outlined below. The appeal must state the specific grounds for the appeal and should include all supporting documentation. The appeal must be postmarked or hand delivered to the appropriate appeal officer, or sent via email, <u>by the deadline provided in the decision letter</u>, which is usually five (5) working days after the date on which notice of the decision is sent to the student. Each student or organization shall be limited to one appeal. The decision of the appeal officer is final.
- In cases involving charges relating to sexual harassment as defined in applicable university policy, the victim may appeal the original decision. Such charges include, but are not limited to, sexual misconduct and stalking.
- A student who (or organization that) has accepted responsibility (Administrative Disposition) for violating the Code of Student Conduct waives the right to appeal, except on the basis that the disciplinary sanction is grossly disproportionate to the violation(s) committed.
- Each party shall be limited to one appeal. The decision of the appeal officer is final.

#### Grounds for appeal

An appeal may be based only upon one or more of the following grounds:

1. Procedural error that resulted in material harm or prejudice to the student (i.e., by preventing a fair, impartial, or proper hearing). Deviations from the designated procedures will not be a basis for sustaining an appeal unless material harm or prejudice results;

2. Discovery of substantial new evidence that was unavailable at the time of the hearing, and which reasonably could have affected the decision of the hearing body; or

3. Disciplinary sanction imposed is grossly disproportionate to the violation(s) committed, considering the relevant aggravating and/or mitigating factors.

# Non-attendance by the accused student may not be the sole grounds for an appeal. Dissatisfaction with a decision is not grounds for appeal.

#### **Appeal Procedure**

- 1. Complete the Appeal Request Form, including signing the form.
- 2. If applicable, attach supporting documentation.
- 3. Turn in the signed form and any added documentation to Student Conduct by the deadline. Student Conduct will ensure that the appeal officer receives the appeal and the record of the case.
- 4. Students neither meet with nor make oral presentations to the appeal officer, except at the request of the appeal officer in order to obtain relevant information.
- 5. Students who do not submit their appeals by the date/time specified in their decision letter waive their opportunity to appeal.
- 6. Students who do not provide information concerning the basis of their appeal waive their opportunity to an appeal.
